# Draft regulatory framework - update

### What changes are we making?





### What changes are we making?



- We will hold ourselves to account about decision timeliness, decisions in writing with reasons, enable internal review of decisions, measure our success as a regulator, collaborate with other regulators, publish progress and decisions, be clear when we are regulating and when we are advising
- Strategic planning clarify what outcomes need to be achieved for strategic planning to be effective and evidence-based, current and flexible assessment of whether utility achieves strategic planning outcomes, no checklists, no prescriptive planning approach, guidance provided
- Dividend payment assessment and approval linked to effective strategic planning

- Section 60 applications assess at early stage, focus on fit for purpose and risks, will not assess cost-effectiveness, technical assessments can be undertaken by external expert or panel
- Monitoring reduced duplication, consider how to best communicate results of inspections
- No changes to trade waste
- Commitment to improve coordination with other regulators





- Sector vision and regulatory objectives and principles
- Regulation of strategic planning
- Dividend assessment (now based on assessment of strategic planning)
- Technical assessment and approvals (s60)
- Inspections of works (s61)
- Trade waste (no change proposed)
- Performance monitoring
- Review of regulatory decisions




- Consultation phase closes 30 April 2022.

- Formal submissions will be made public; survey responses not – all to be included in high level feedback summary.




### Next steps - Dealing with submission/feedback



#### **Update:**

- Embedded in the production of internal and external guidance, processes and templates as well as internal performance monitoring – strong continuous improvement focus
- Implementation and transitional planning for the new Regulatory Framework underway
- Continuing the journey started last year with collaboration skills training
- In discussions about resources, staff training and development, internal systems and documentation
- Organisational design to test appropriate structures
- Maintenance of DPE Water Utilities team support and advisory functions

#### TWRRP evaluation framework - summary



Aither engaged to evaluate the Town Water Risk Reduction Program (TWRRP). Final evaluation report due August.

#### Scope:

- Prepare evaluation framework for 2022 evaluation, and any future evaluations if needed
- Undertake 2022 evaluation, drawing on various methods (consultations, interviews, surveys, published documents, etc.)
- Prepare a framework to guide evaluation of TWRRP pilot programs (Pilot program evaluation is not in Aither's scope).


#### Evaluation purpose:

- Understand achievement of foundational outcomes.
- Identify actions/outputs delivered through the program so far, and consider how effective these have been in contributing to foundational outcomes and expected contribution to intermediate and ultimate outcomes.
- Identify recommendations for the future, including what needs to be done to maintain outcomes achieved to date and to achieve further outcomes in the future.
- Provide findings and recommendations to inform Phase 2 of the Town Water Risk Reduction Program.

#### Conceptual program logic for the TWRRP








#### Detailed program logic for the TWRRP







### Proposed key evaluation questions



#### Appropriateness of the TWRRP design to the need

- To what extent does the program address the risk identified at the beginning and during the program? Did the beneficiaries think it was worthwhile?
- To what extent are the program activities still valid/needed for the future, considering the emerging needs of local water utilities and communities affected? What does the department need to do differently or in addition to actions/outputs delivered to date?

#### Efficiency in TWRRP delivery

• Has the program used resources wisely? Is there anything that could be done differently or better?

#### Effectiveness in delivering actions/outputs

- To what extent have actions/outputs been delivered as intended and in accordance with expected timelines?
- To what extent have external factors or barriers affected delivery of outputs? If needed, how can the program be improved to respond to these?

#### Equity in access to the TWRRP

To what extent is the program reaching intended recipients?

#### Effectiveness in achievement of outcomes

- What outcomes have been observed as a result of the TWRRP? What unintended outcomes (positive or negative) have arisen, if any?
- To what extent have external factors or barriers influenced outcomes? If needed, how can the program be improved to respond to these?

#### Equity in sharing benefits

To what extent have LWUs benefited from the program according to their needs?





- A separate regional collaboration focussed pilot has been established under the TWRRP skills and training workstream
- Involving Orana Water Utilities Alliance Councils (Bourke, Bogan, Brewarrina, Bourke, Central Darling, Cobar, Coonamble, Gilgandra, Mid-Western, Narromine, Walgett and Warrumbungle Councils
- We are also running a remote technology pilot with Bourke and Cobar councils, which is being delivered by Veolia.
- The Water Utilities team are separately trialling remote headsets in their work with local water utilities.

# Operator training – update



### Operator training - update



- Addressing the major barrier for registered training organisations (RTOs) to offer comprehensive operator training – access to high quality training and assessment training documents
  - engaging with RTOs and sector to identify a fast track to update and share resources
  - consultant to develop options for a national model for sharing and maintenance of units in the national water training package.
- Engaging with TAFE to ensure that training is responsive to local water utility and sector needs
- We propose the department transitions to VET principals for future training to support the local water utilities and RTOs for operator training and development. The department is also developing other bespoke training for local water utilities in response to emerging

risks.

# WaterNSW pilots - updates

## WaterNSW pilots - update



#### Dam Safety pilot (Commenced)

- Idea originally proposed by Clarence Valley Council in August 2021 consultation, following concerns about the resourcing impacts of recent Dams Safety NSW regulatory requirements/audit findings.
- The pilot will involve three councils that have recently gone through a Dams Safety NSW audit process (Clarence Valley, Orange City and Tamworth Regional).
- Commenced in April 2022.
- WaterNSW has organised site visits with the participating councils in late April and early May 2022.
- Finalisation of the pilots expected in July 2022.

## WaterNSW pilots - update



#### River operations pilot (Confirmed)

- Identified opportunities to leverage WaterNSW river operations including water quality and quantity monitoring, analysis of information, and decision-making support.
- WaterNSW has finalised scope with Hay and Murrumbidgee councils
- Final arrangements to be made with DPE for funding but project is commencing late April 2022.

## WaterNSW pilots - update



#### **Catchment management water quality pilots (Confirmed)**

- WaterNSW is proposing to work with Tweed Shire Council to assist them to develop an approach to catchment based water quality management.
- WaterNSW will utilise its Greater Sydney catchment and water quality expertise to work with TSC to identify key risks and mitigations.
- NSW Health will be a partner due to its role in regulating water quality, as well as other groups such as county councils and Aboriginal land councils.
- WaterNSW will also assist Kyogle Council on specific areas of risk.
- Richmond Valley has decided not to participate due to flood recovery.
- Scoping discussions have been completed between the TWRRP and WaterNSW, and WaterNSW will
  contact Kyogle and Tweed soon to progress.
- Pilot expected to commence in late April/early May 2022.


