# Water supply work approval to take groundwater under a domestic and stock right

Use this form to apply for a new or amended water supply work approval under a domestic and stock right under section 92 of the *Water Management Act 2000* (WM Act).

A water supply work approval to take groundwater under a domestic and stock right allows you to construct a work which takes water from an aquifer, such as a water bore.

Water taken from the work can only be used for domestic consumption and stock watering.

# Who can apply?

Any person can apply for a water supply work approval to take groundwater under a domestic and stock right.

Only the owner or occupier of a landholding has a domestic and stock right to take and use water for domestic consumption and stock watering.

# Who can use this application form?

Responsibilities for granting and managing water supply work approvals and water use approvals are shared between the NSW Department of Climate Change, Energy, the Environment and Water (the department) and WaterNSW.

This application form is for use by the department's customers:

- government agencies, including other NSW government agencies, local councils, and the Commonwealth
- state-owned corporations
- water utilities, water supply authorities and licensed network operators under the Water Industry Competition Act 2006
- · mining activities



- irrigation corporations
- public schools and hospitals
- Aboriginal communities and businesses.

# Offences and penalties

It is an offence, under section 344 of the *Water Management Act 2000*, to make a statement that you know to be false or misleading in, or in connection with, this application. A corporation found guilty of an offence against section 344 is liable to a penalty not exceeding \$2.002 million. An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$500,500.

An access licence or approval may be suspended or cancelled under the *Water Management Act* 2000 in certain circumstances. These include if the holder of the license or approval is convicted of an offence under that Act.
