

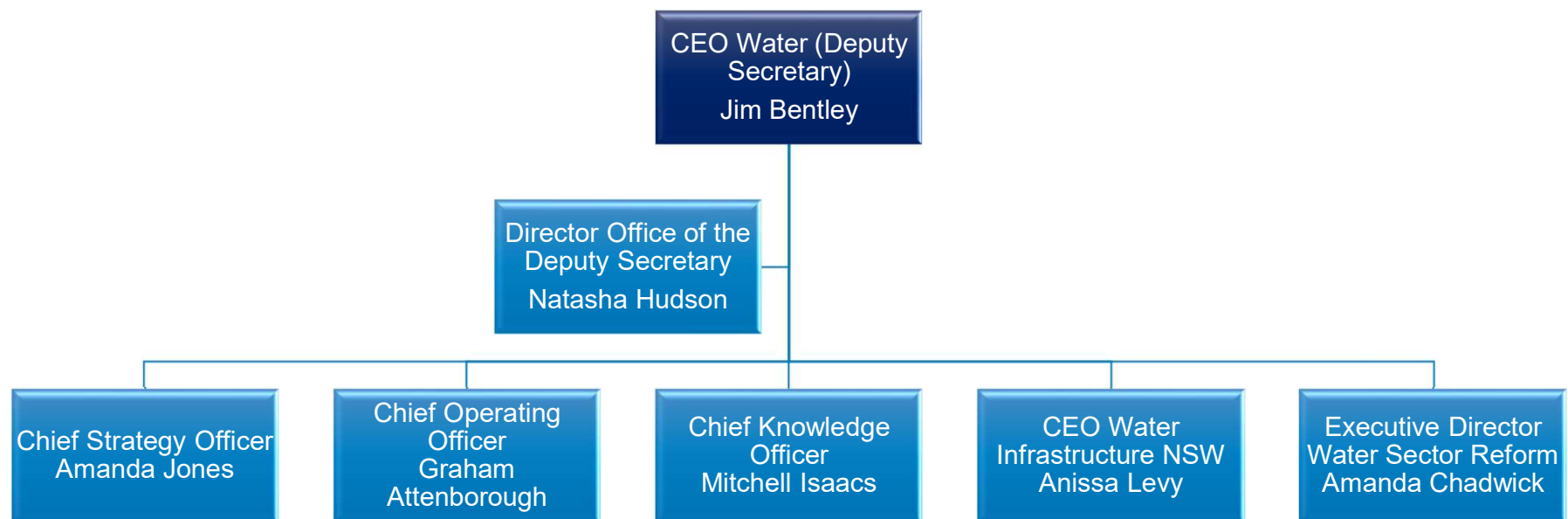

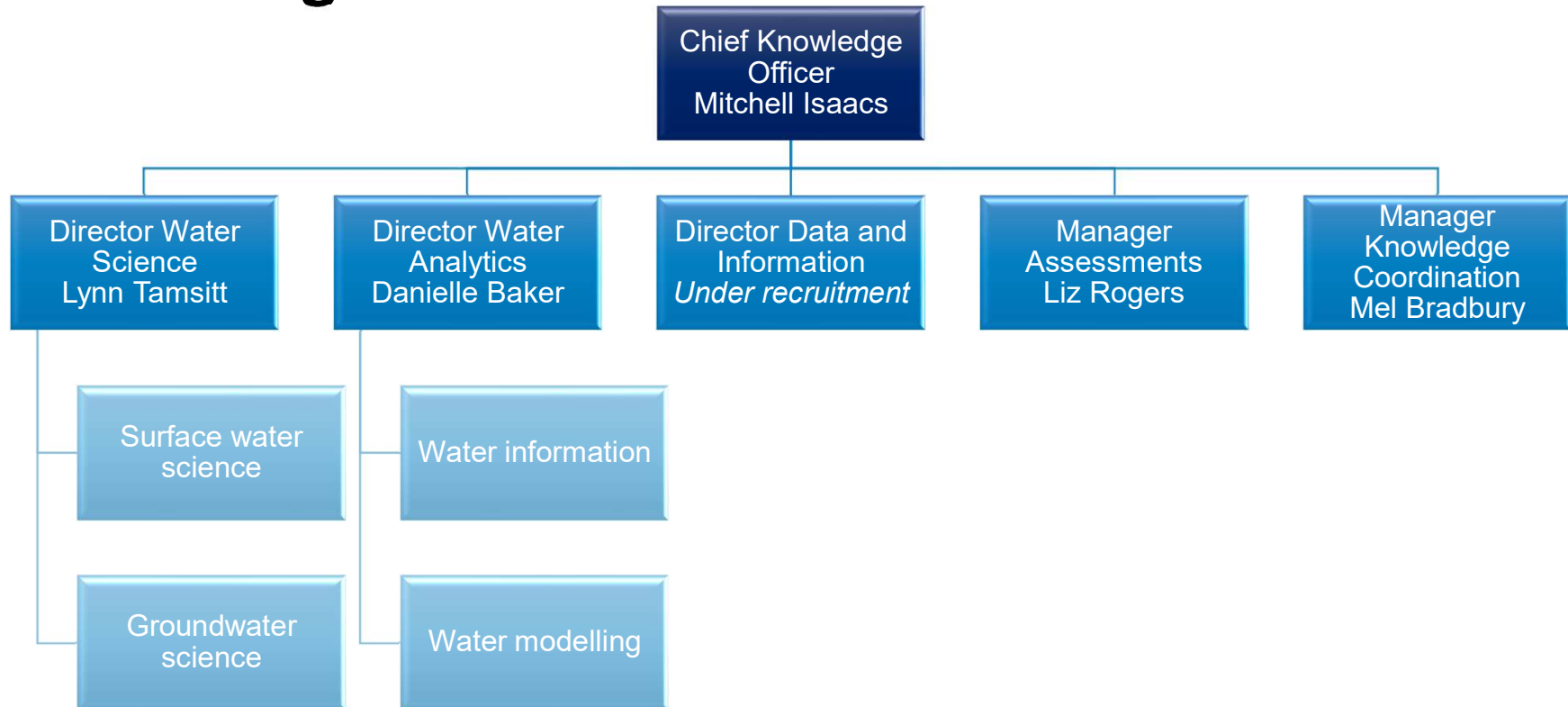

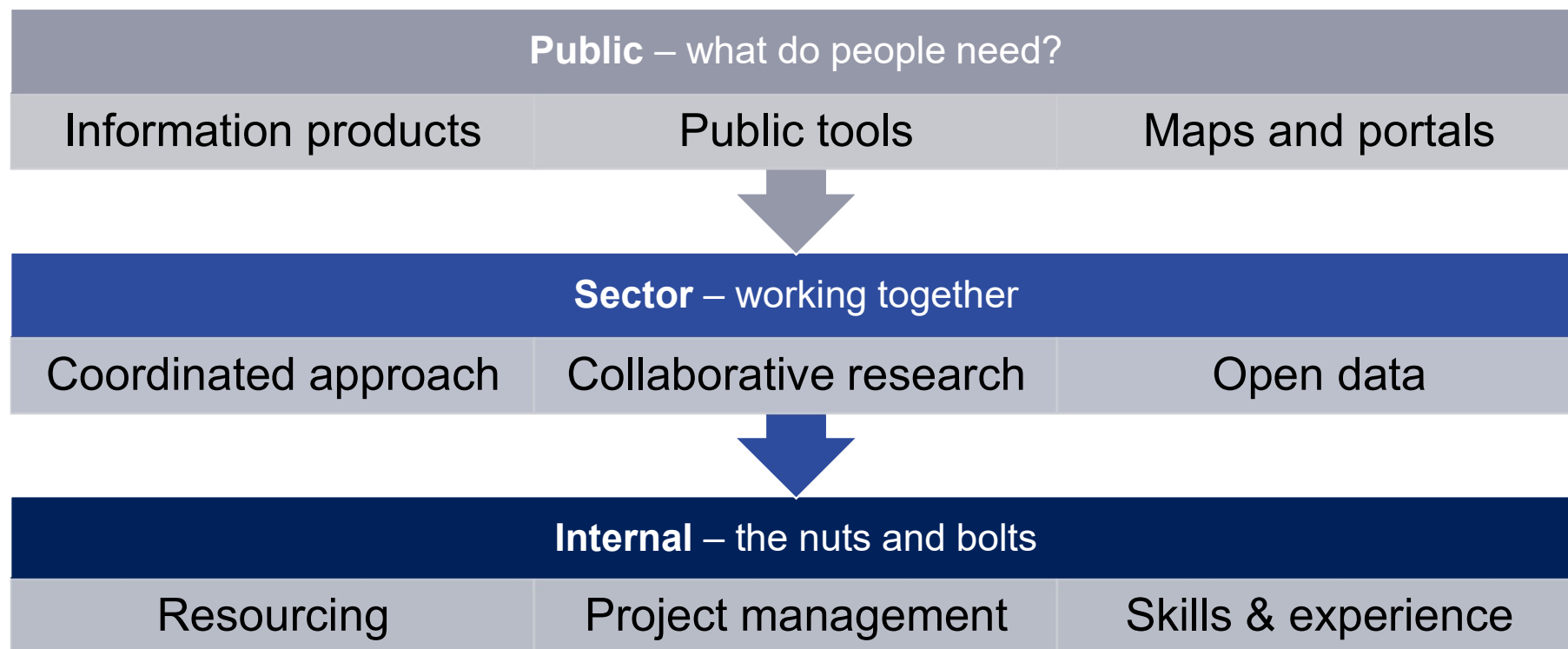

Transparency consultation

- Summary and results dashboard online
- Currently working on improvements
- Some observations include:
 - Most info people want is available but can be hard to find
 - Existing tools need improvements (clunky, hard to navigate etc)
 - Support for all licences to be treated equally
 - Strong support for intended use to be published
 - Low awareness of some tools eg WaterInsights 39%, Usage (38%) and Trade (32%) dashboards

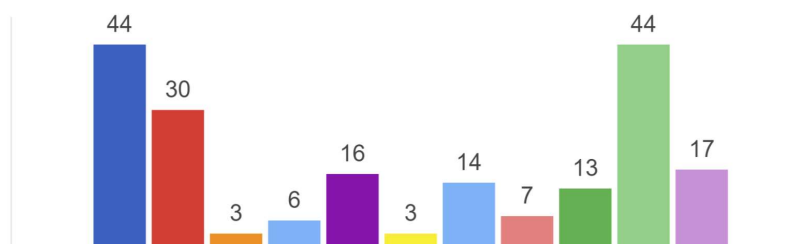

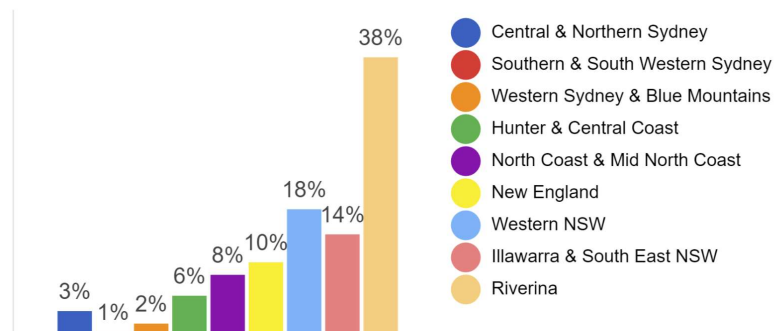

Capacity you participate in water markets

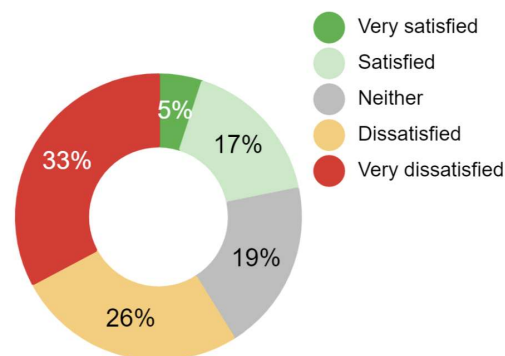


- Irrigator who HAS bought or sold water in the last 12 months

Surveys by postcode region



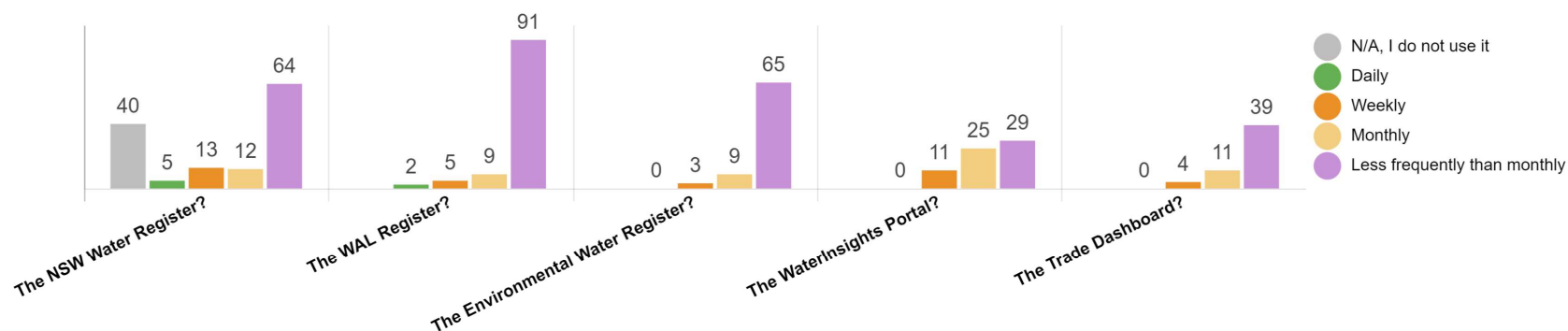
Satisfied with access/usability of information



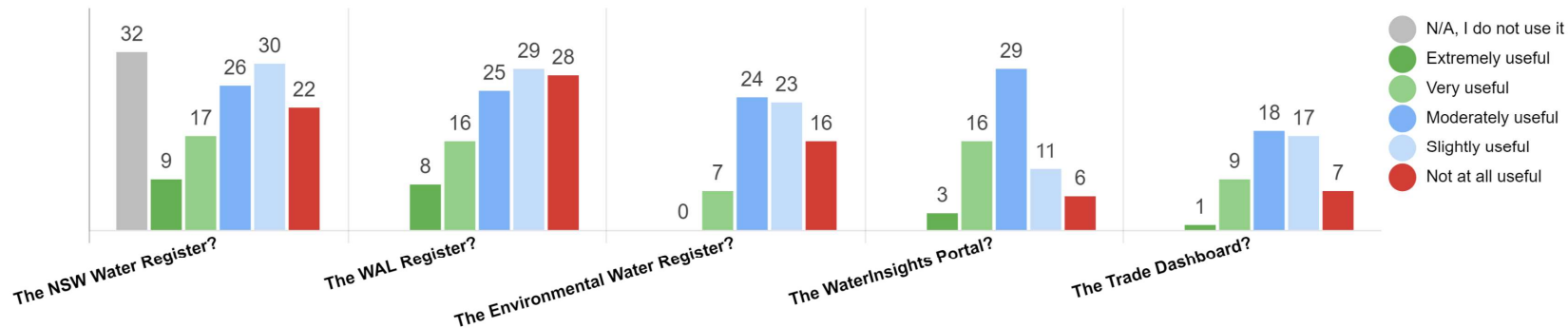

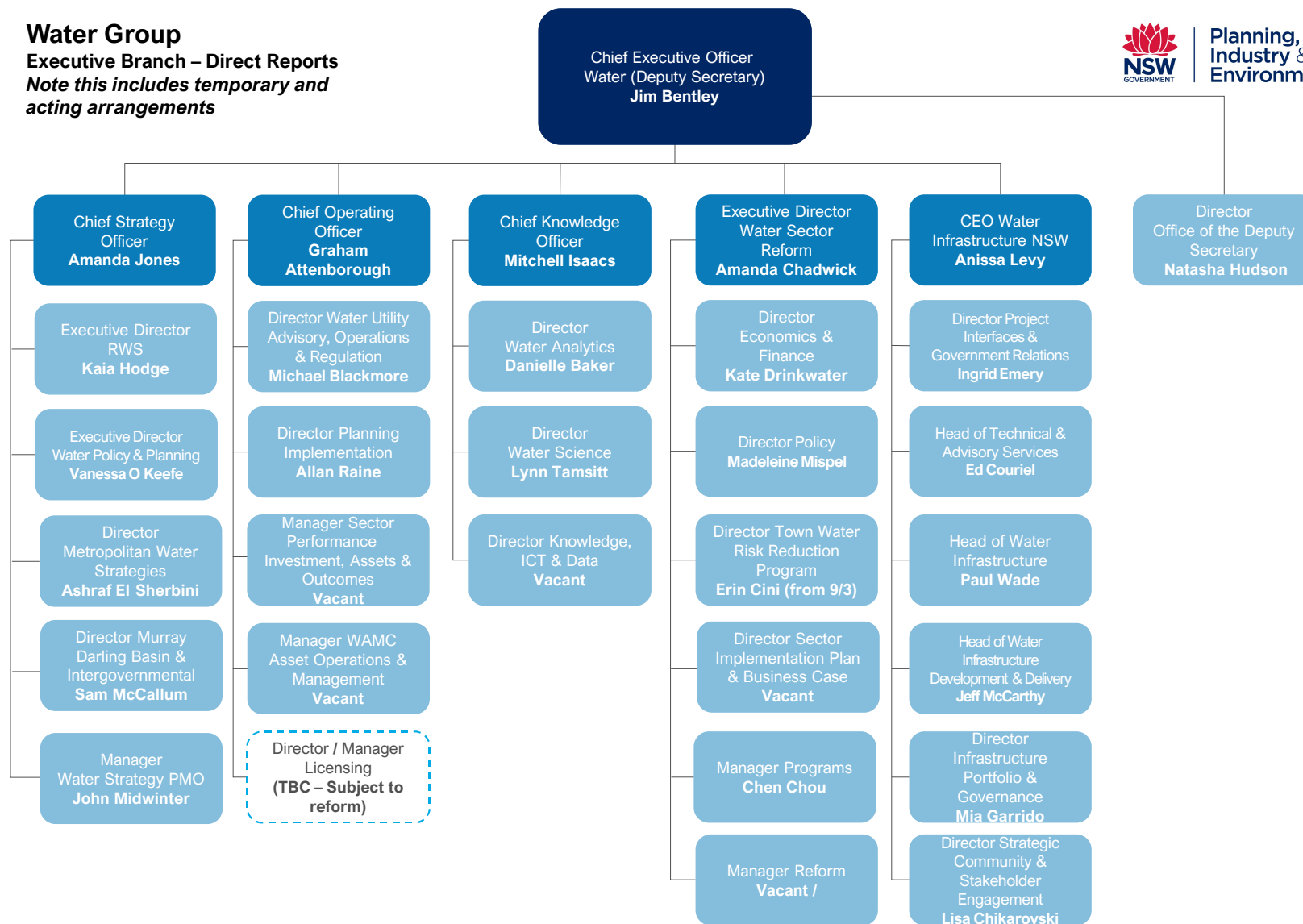
